Limited Warranty

PLEASE READ THIS LIMITED WARRANTY CAREFULLY BEFORE INSTALLING OR USING ANY PERFORMANCE EXHAUST MANIFOLD SUPPLIED BY FULL TILT PERFORMANCE. BY INSTALLING OR USING ANY SUCH MANIFOLD, YOU ACCEPT, ACKNOWLEDGE, AND AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS LIMITED WARRANTY.

**LIMITED WARRANTY
(Full Tilt Performance Exhaust Manifolds)**

Full Tilt Performance (“FTP”) warrants each Full Tilt Performance Exhaust Manifold (including the FTP-supplied piece-parts supplied therewith, a “Manifold”), at the time of retail purchase, to be free from manufacturing defects for a period of two (2) years from the original purchase date, subject to the limitations, exclusions and other provisions below.

This limited warranty is given solely for the benefit of the original retail purchaser and may not be assigned, in whole or in part, without the prior written consent of FTP. For purposes of this limited warranty, “original retail purchaser” means the person that first purchases a Manifold for use and not for resale. Any other user or subsequent purchaser of a Manifold is referred to herein as a “subsequent user.” This limited warranty does not apply to any Manifold that has been altered, refurbished, or damaged through negligence, abuse, improper use, shipping, storage, fire, flood, earthquake, or other act of God.

FTP’s sole liability, and the original retail purchaser’s exclusive remedy, pursuant to this limited warranty is the repair or replacement, at FTP’s election, of a Manifold shown to FTP’s reasonable satisfaction to have been defective at the time of delivery by written notice received by FTP no later than two (2) years after the date of retail purchase of such Manifold.

THE WARRANTIES, OBLIGATIONS AND LIABILITIES OF FTP AND THE REMEDIES OF THE ORIGINAL RETAIL PURCHASER SET OUT IN THIS LIMITED WARRANTY ARE EXCLUSIVE, EVEN THOUGH THEY MAY FAIL THEIR ESSENTIAL PURPOSE, AND ARE MADE AND ACCEPTED BY THE ORIGINAL RETAIL PURCHASER AND ANY SUBSEQUENT USER, IN LIEU OF, AND ORIGINAL RETAIL PURCHASER AND ANY SUCH SUBSEQUENT USER WAIVES AND RELEASES ALL OTHER WARRANTIES, OBLIGATIONS AND LIABILITIES OF FTP AND ALL OTHER CLAIMS AND REMEDIES OF ORIGINAL RETAIL PURCHASER AND ANY SUCH SUBSEQUENT USER, EXPRESS OR IMPLIED, ARISING BY STATUTE OR OTHERWISE, WITH RESPECT TO ANY MANUFACTURING DEFECT IN THE MANIFOLD, INCLUDING BUT NOT LIMITED TO THE WAIVER AND RELEASE BY ORIGINAL RETAIL PURCHASER AND ANY SUCH SUBSEQUENT USER OF THE FOLLOWING: (I) ANY STATUTORY OR IMPLIED WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR ANY PURPOSE, AND (II) ANY IMPLIED WARRANTY ARISING FROM COURSE OF DEALING, COURSE OF PERFORMANCE OR USAGE OF TRADE.

FTP SHALL NOT HAVE ANY OBLIGATION OR LIABILITY AND ORIGINAL RETAIL PURCHASER AND ANY SUBSEQUENT USER ACKNOWLEDGES THAT FTP SHALL NOT HAVE OBLIGATION OR LIABILITY WHATSOEVER TO ORIGINAL RETAIL PURCHASER, TO ANY SUBSEQUENT USER OR TO ANY PERSON CLAIMING BY, THROUGH OR UNDER ANY OF THEM, WHETHER ARISING PURSUANT TO THE FOREGOING LIMITED WARRANTY, OR IN CONTRACT, INDEMNITY, TORT (INCLUDING NEGLIGENCE), PRODUCTS LIABILITY, STRICT LIABILITY, OR OTHERWISE, FOR ANY EXEMPLARY OR PUNITIVE DAMAGES OR FOR ANY SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES (EVEN THOUGH SUCH DAMAGES MAY BE FORESEEABLE) INCLUDING, BUT NOT LIMITED TO: LOSS OF PROFITS OR REVENUES; PERSONAL INJURY; LOSS OF USE OF EQUIPMENT; COST OF CAPITAL; COST OF SUBSTITUTE EQUIPMENT, REPAIRS OR FACILITIES; COST OF DOWNTIME; COST OF PURCHASED OR REPLACEMENT EQUIPMENT OR PARTS; COST OF TRANSPORTATION; COST OF FREIGHT, INSPECTION, INSTALLATION, OR REMOVAL OR REINSTALLATION WITH RESPECT TO THE MANIFOLD.

In the event that any provision, term, disclaimer, limitation or condition of this limited warranty is declared void, unenforceable, or against public policy, then said provision, term, disclaimer limitation or condition shall be construed as though it did not exist and shall not affect the remaining provisions, terms, disclaimers, limitations or conditions of this limited warranty and the same shall be interpreted as far as possible to give effect thereto. Any implied warranties that cannot be legally disclaimed under applicable law shall nonetheless be limited in duration to the warranty period set forth above. No agreement varying or extending the foregoing limited warranty or the remedies, exclusions or limitations set out in this limited warranty shall be effective unless signed by an authorized officer of FTP.

To obtain service under this limited warranty:

- 1) Contact FTP or the dealer from whom the Manifold was purchased within 30 days of discovery of the suspected defect. Be prepared to show that you are the original retail purchaser of the Manifold.
- 2) FTP, with your dealer’s assistance, if applicable, will gather all pertinent information regarding the claim and inspect the Manifold.
- 3) If FTP affirms that the Manifold is eligible under the conditions of this limited warranty, FTP will promptly determine whether to repair or replace the defective Manifold.
